**ANNOUNCEMENT**  
**ADJUSTMENT OF CONVERSION PRICE OF US\$150,000,000**  
**6.5% CONVERTIBLE BONDS DUE 2017**

In accordance with the CB Terms and Conditions, as a result of the declaration of the Final Dividend by the Company, the Conversion Price will be adjusted from HK\$6.81 per Share to HK\$6.33 per Share with effect from 27 May 2013, being the business day immediately after the record date in connection with such declaration.

Reference is made to the announcement (the “**CB Announcement**”) of China Hongqiao Group Limited (the “**Company**”) dated 21 March 2012 in relation to the issue by the Company of the US\$150,000,000 6.5% convertible bonds due 2017 (the “**Convertible Bonds**”), the announcement made by the Company on 23 May 2012 in relation to adjustment of conversion price of the Convertible Bonds for year 2011, and the results announcement of the Company for the year ended 31 December 2012 dated 8 March 2013 (the “**Results Announcement**”). Capitalised terms used herein have the same meaning as those defined in the CB Announcement, unless otherwise defined herein.

**ADJUSTMENT OF THE CONVERSION PRICE RELATING TO THE CONVERTIBLE BONDS**

The terms and conditions of the Convertible Bonds (the “**CB Terms and Conditions**”) provided, among other things, that if the Company pays or makes any Capital Distribution (as defined in the CB Terms and Conditions) to the shareholders of the Company (the “**Shareholders**”), the Conversion Price shall be adjusted by multiplying the Conversion Price in force immediately before such Capital Distribution by the following fraction:

$$\frac{A-B}{A}$$

Where:

A is the Current Market Price (as defined in the CB Terms and Conditions) of one Share on the date on which the Capital Distribution is publicly announced; and

B is the Fair Market Value (as defined in the CB Terms and Conditions) on the date of such announcement of the portion of the Capital Distribution attributable to one Share.

Such adjustment shall become effective on the date that such Capital Distribution is actually made or if a record date is fixed therefor, the business day immediately after such record date.

As announced in the Results Announcement, the board of directors (the “**Board**”) of the Company recommended the declaration of a final dividend of HK\$26.0 cents per Share for the year ended 31 December 2012 (the “**Final Dividend**”). Pursuant to the CB Terms and Conditions, the Final Dividend fall within the definition of Capital Distribution. Accordingly, the Conversion Price per Share will be adjusted from HK\$6.81 to HK\$6.33 effective from 27 May 2013 (Hong Kong time), being the business day immediately after the record date in connection with the declaration of the Final Dividend (the “**Adjustment**”). Apart from the Adjustment, there is no change in the CB Terms and Conditions.

As at the date of this announcement, the total number of the issued Shares of the Company is 5,885,000,000 Shares, and none of the Convertible Bonds has been converted into Conversion Shares. Following the Adjustment, the number of Conversion Shares issuable by the Company upon full conversion of the Convertible Bonds will increase by 12,965,058 Shares and the maximum number of Conversion Shares to be issued by the Company upon full conversion of the Convertible Bonds will become 183,940,758. Such Conversion Shares will be issued and allotted pursuant to the general mandate granted by the Shareholders to the Directors in the annual general meeting of the Company held on 7 May 2013.
